

## WHAT TO BRING TO YOUR TAX APPOINTMENT

Current Picture I.D. (driver's license, passport, state issued identification card) **For 2022, even if we have known you for years!**

Social Security Card (you **must** bring either an original card, a copy of the card or a copy of last year's tax return) for yourself and all family members you are claiming, or ITIN's **unless they are already on file.**

Dates of birth for yourself and all family members you are claiming.

If you are a **new** client, please bring copies of the last 3 years tax returns.

Copies of dependent children's current year tax returns if they have filed before you file.

W-2s for **all** jobs you held in 2022 and any other tax related documents.

Form 1099-G, if you received unemployment insurance in 2022

Form 1099-INT, if you received interest from a bank account in 2022

Form 1099-DIV. if you received and dividends

All Forms 1099-B for stock and investment sales

Form 1099-K Payment Card and Third-Party Network Payments

Form 1099-Misc

Form 1099-NEC

Any information pertaining to Virtual or Crypto Currency transactions

Form 1095-A if health insurance was obtained through the exchange

Form 1098-T for tuition and fees, **also bring in the receipts for this and for books or course supplies purchased .**

If you are claiming childcare expenses, documentation of expenses and childcare agency's ID or Social Security number of provider.

If you have rental income please provide the **number of days** each property was in rental use and **complete the rental worksheet**

Please bring the receipts for supply and repair items that are in excess of \$2500 that pertain to your business or rental expenses.

If claiming **Earned Income Tax Credit, Child Tax Credit or the College Credits** please provide evidence of child residing at your address. (school records, medical records, etc.) **Proof is required for all 3 credits.**

**Head of household filing status will also require us to file a Form 8867, so please see the list below of examples of documents that you may need to provide in order to claim this filing status.**

A voided check or deposit slip for direct deposit of your refund.

Form 1098-T for tuition and fees. **Also bring in the receipts for this and for books purchased .**

If you are claiming childcare expenses, documentation of expenses and childcare agency's ID or Social Security number of provider.

If you have rental income please provide the **number of days** each property was in rental use **and complete the rental worksheets.**

Please bring the receipts for supply and repair items that are in excess of \$2500 that pertain to your business or rental expenses.

If claiming **Earned Income Tax Credit, Child Tax Credit or the College Credits please provide evidence of child residing at your address. See list below examples of documents you will need to provide. For 2021.....proof is required for all 3 credits.**

## Documentation List:

The following are examples of documents that we may rely on to determine a taxpayer's eligibility to claim the credit(s), and/or HOH filing status and the amount(s) of any credit(s) claimed. This list is not all-inclusive and none of

these documents are specifically required to demonstrate eligibility for the credits and/or HOH filing status. We are required to keep copies of these for 3 years, so please provide actual documents to be copied.

## Residency of a Qualifying Child

- School records or statement from school
- Landlord or a property management statement.
- Health care provider statement.
- Medical record showing child's name, your address and dated in 2021

- Childcare provider records.
- Placement agency statement.
- Social service records or statement. (Medicaid/Chip)
- Place of worship statement.
- Indian tribal official statement.

### **Disability of Qualifying Child**

- Statement from medical doctor.
- Statement from other health care provider.
- Statement of social services agency or program statement.

### **Schedule C – Self Employment**

- Business license.
- Forms 1099.
- Records of gross receipts provided by taxpayer.
- Taxpayer's summary of income or summary of income provided by taxpayer, Form 1099-Misc
- Records of expenses provided by taxpayer.
- Taxpayer's summary of expenses or summary of expenses provided by taxpayer.
- Bank statements to show income and expenses.

### **Head of Household**

You must meet all three:

1. Taxpayer was unmarried or considered unmarried
2. Taxpayer provided more than half of the cost of keeping up a home for the year for a qualifying person
3. A qualifying person lived with you in the home for more than half the year (except for temporary absences, such as school). However, if the qualifying person is your dependent parent, he or she doesn't have to live with you.

**See the worksheet below to help determine if you provided more than half of the cost of keeping up a home.**
